### Instructions

Within the scope of Article 11 of the Protection of Personal Data Law No. 6698 ("PDPL"), everyone has the right to apply to the Besiktas Shipyard Inc. ("Besiktas Shipyard") for the following matters:

- a) to learn whether his/her personal data are processed or not,
- b) to demand for information as to if his/her personal data have been processed,
- c) to learn the purpose of the processing of his/her personal data and whether these personal data are used in compliance with the purpose,
- d) to know the third parties to whom his personal data are transferred in country or abroad,
- e) to request the rectification of the incomplete or inaccurate data, if any,
- f) to request the erasure or destruction of his/her personal data under the conditions referred to in Article 7,
- g) to request reporting of the operations carried out pursuant to sub-paragraphs (d) and (e) to third parties to whom his/her personal data have been transferred,
- h) to object to the occurrence of a result against the person himself/herself by analysing the data processed solely through automated systems,
- i) to claim compensation for the damage arising from the unlawful processing of his/her personal data.

### Processing of Personal Data Related to the Application

With the Application Form to Data Controller, personal data (name, surname, TR ID number, passport number, telephone number, e-mail, address, signature) are processed within the scope of "It is necessary for compliance with a legal obligation to which the data controller is subject", one of the data processing conditions stipulated in the PDPL, in order to identify the applicant and manage the application. Processed personal data can only be shared with relevant units/individuals and institutions/organizations authorized by law, if necessary.
